[Fox Valley United Way SPARK Aurora](#)

An education initiative of Fox Valley United Way, SPARK (Strong, Prepared and Ready for Kindergarten) connects underserved Aurora, Illinois, families with early education and childcare opportunities that prepare their young children for success in school and life. SPARK creates collaborations that shape future outcomes for children. We raise awareness of the value of early childhood development, influence social policy and coordinate resources for parents. We also help early childhood teachers and childcare providers enhance their professional skills.

We help families move from temporary housing to their own apartments, provide clothing, school supplies and many other individualized things to help a student succeed. We help students and their families on a case by case basis to make sure students are ready and excited to learn and thrive. We work directly with BPS101 to help with mentor projects and other activities that help students on free/reduced lunch or who are in temporary housing.

[Batavia Interfaith Food Pantry and Clothes Closet](#)

The Pantry and Closet together comprise a not-for-profit organization sponsored by various Batavia churches and the community at large. Its purpose is to provide food, non-food household and personal items, and clothing for those individuals and families residing in Batavia and Batavia Township who are in need. The Pantry's not-for-profit operations fall under the "The Federal Bill Emerson Good Samaritan Food Donation Act" of 1996 which clarifies that clients accept all donations with a clear understanding that they will hold harmless the Pantry, its directors, staff, volunteers, and suppliers.

Refuge for Women is a non-profit, faith based organization providing specialized long-term care for women who have escaped human trafficking or sexual exploitation. With multiple locations across the U.S., Refuge for Women offers up to twelve months of safe housing, at no charge to the resident, with around the clock care as clients progress through evidence-based, trauma-informed programming. The compassionate staff is trained to help residents work through the program to reclaim their identities and reach their goals to overcome addictions, heal from trauma and develop life skills leading to healthy, balanced living and financial independence. Refuge for Women strives to help each woman complete the program with a vision for her future, equipped to succeed and sustain a life marked with dignity and hope.

We are a non-for profit organization dedicated to giving vision, direction, and structure to young Latinas. Our mission is to become a powerful catalyst for Latinas ages 15-25 to pursue their dreams by providing educational leadership platforms, mentorship, and powerful experiences through the context of sisterhood.
